Scholarship applications are distributed to all students in May. The Big Dog Committee meets once a year in June to award scholarships. We also meet during that time to review all current students receiving Big Dog funding. The committee reviews their application materials, grades and financial aid award letter. This allows us to gain more context on the student's financial need, academic commitment and personal character. Once decisions are made all recipients are asked to come to campus to sign their contracts and tell us how they are going to "give back" or "pay back" the loan portion of the award. A percentage of the award is loan, so we ask the students to "pay back" this portion by volunteering at KIPP schools. KIPP Through College (KTC) will make check requests for all students once they arrive on their college campuses

in the fall. The Big Dog award is split into two disbursements: fall semester and spring semesters. KTC waits for the student's fall semester grades to be mailed to us in January by the student before requesting the second half of the award for the spring semester. A student can renew their award if they are in good academic standing and giving back to KIPP. KTC works with the students to ensure that we have their spring semester grades.

KIPP, the Knowledge Is Power Program, is committed to developing in underserved students the academic skills, intellectual habits, and qualities of character necessary to succeed at all levels of pre-kindergarten through 12th grade, college, and the competitive world beyond.

KIPP Houston Public Schools include primary schools, middle schools, high schools, and the KIPP Through College alumni program and focus on academic and character development for underserved students in the Houston area. All KIPP schools follow an extended school day and year model. The school day begins at 7:30 a.m. and ends at 5:00 p.m. and includes an extra month of learning in the summer. All KIPP students, parents, and teachers sign a Commitment to Excellence pledge in which they commit to do whatever it takes for themselves and their teammates to learn and prepare for college. In Houston, approximately 7,700 students were enrolled in grades pre-kindergarten through 12th grade for the 2011-12 school year; 62% of those students self-identified as Hispanic, 36% as African-American, 1% as Caucasian, and 1% as Asian. 89% of 2011-12 students were eligible for the federal free and reduced meals program.

KIPP Houston's early childhood and elementary schools nurture and guide the children's innate sense of curiosity to learn about their world, community, and themselves.

KIPP Houston's middle schools focus on remediation in the early grades and advanced critical thinking skills in the later grades with outstanding results.

The ultimate measurement of KIPP's success is graduation from college. Although 90% of KIPPsters come from economically disadvantaged families, 95% of KIPP Houston Public Schools students (tracking from the 8th grade) graduate from high school; and 90% have matriculated to a higher education institution. Once in college, KIPP alumni continue to defy the odds. 45% of alumni (tracking from 8th grade) who are old enough to have graduated, have graduated from college and another 18% are still persisting. This is a college graduation rate more than five times the graduation rate of comparable low-income students in our country and 14 points higher than the national average for students across all income brackets.
